How does my gift help?

Your gift to the Community Childcare of Manchester Endowment Fund is invested and grows forever to provide future financial stability for Carousel Child Care Center and StoryLand Child Care.

How is my fund directed?

The fund is directed by the Community Childcare of Manchester Board of Directors, which makes recommendations for use of the fund's annual payout in accordance with the centers' needs.

How do endowments work?

Endowment funds are invested by our professional wealth managers in a diversified portfolio and pay out a percentage of interest annually. The remainder is reinvested to ensure that funds exist in perpetuity.



How do I make a gift?

We welcome gifts at any time and accept cash as well as stocks, bonds and IRAs. Donors may name and honor or remember friends and family through their gifts or name the endowment in their will to create a legacy that will forever benefit the community.

What is Endow Iowa?

Endow Iowa is a 25% state tax credit for gifts of \$50 or more to endowed funds. Upon receipt of your gift to the Community Childcare of Manchester Endowment Fund, you will receive a voucher that can be used the same as cash to pay your state tax. Gifts up to \$1.2 million per individual or \$2.4 million per couple are eligible for Endow Iowa each year.
